## **1523 DECLARATIONS OF INTEREST.**

No declarations were made.

## **1524 MINUTES.**

The minutes of the meeting held on 2 November 2023 and the extraordinary meetings held on 23 November 2023 and 6 December 2023 were approved for signature by the Chairman.

## **1525 DISTRICT REPORT.**

It was reported that grants are available through Rushcliffe Borough Council for properties that were recently flooded grant aid for business similarly affected. It is hoped that Strawberry Wood can be acquired for management as an open space for the benefit of the community. There has been no change to the Local Development Order for the power station site, a planning application is expected soon for the extraction of gypsum by open cast mining on the site close to the power station.

## **1526 COUNTY REPORT.**

It was reported that an application has been made for a 40 mph speed limit on the road between East Leake and West Leake. It was agreed that the Parish Council would support this proposal.

## **1527 PARISH BOUNDARY REVIEW.**

Feedback was provided on a recent meeting with officers of Rushcliffe Borough Council concerning a proposal to remove the area covered by Fairham from the parish. It was considered that the application could be made around September 2024. It was agreed that this proposal be submitted to the Village Meeting for consideration.

**1528 FLOODING AND DRAINAGE.**

Following the recent flooding, for which part of the explanation was blocked drainage ditches and culverts it was agreed to approach VIA to see if it would be able to assist in dredging to improve the flow of water.

**1529 AIRPORT CONSULTATIVE COMMITTEE.**

It was reported that the Airport Noise Action Plan was at the draft stage. A review of the timings and direction of the Ryanair training flights was being carried out for the end of 2024.

**1530 FINANCE.**

The clerk circulated a statement setting out payments and receipts to 31 December 2023. It was agreed that the report be noted.

Cheques totalling for £100 were approved for payment.

The precept for 2024 – 2025 was agreed at £5,446, zero percent increase.
