1579 **DECLARATIONS OF INTEREST.**

No declarations were made.

1580 **MINUTES.**

The minutes of the meeting held on 4 September 2024 were approved for signature by the Chairman.

1581 **DISTRICT REPORT.**

It was reported that Rushcliffe's current chief executive will be leaving for a post in Lincolnshire and that his replacement will be Adam Hill from Mansfield. A training session on domestic abuse has been arranged to take place at Cotgrave in February. A response has been given to the Greater Nottingham Plan. Rex wishes everyone a Merry Christmas.

1582 FAIRHAM GROWTH BOARD.

More movements of topsoil are taking place on the site off Green Street. Further work on the roads and sewers will take place during 2025. Changes are required to the loop road at the junction. Traffic lights will be in place at the Mill Hill roundabout by 2027. Greenbelt have commenced landscaping and there will be a charge of £154 per annum for each house on the development, but there may be additional charge for the maintenance of land reserved for the builders. Properties should start to be occupied in the period leading up to Christmas. The neighbourhood centre is expected to include a hotel, shops and a care home.

1583 MILL HILL QUARRY.

A Regulation 25 request has been received although it is not clear what the deadlines are for responding. It is likely to be thirty days although unlikely to commence before Christmas. A new local aggregates assessment will also be requested.

1584 FIVE PARISHES GROUP.

A Section 25 notice has been received for the proposed gypsum quarry.

1585 WAR MEMORIAL TREES MANOR ROAD.

It was agreed to commit up to £500 for the replacement of two of the trees dedicated to Barton men killed in World War One.

1586 CUTTING OF GRASS, TOP OF NEW ROAD.

It was agreed to commit a further £100 for the maintenance of the grass at the top New Road, work to be carried out when ground conditions are fit for the purpose

1587 OLD PHONE BOX MANOR ROAD.

The paint has been acquired to repaint the old phone box and quotations will be sought to enable the work to be carried out.

It was agreed to purchase sufficient large poppies to fix to the Village's lampposts for the 2025 Remembrance Day event.
